**TENDER DOCUMENT FOR FIRE ALARM SYSTEM IN THE OFFICE OF  
SPPL, MUMBAI**

1. Shivshahi Punarvasan Prakash Ltd. (SPPL) intends to select firm for Annual Maintenance Contract for Fire Alarm System in the office of SPPL for a period of 12 months. For this purpose SPPL intends to solicit /Price bids from prospective Service Provider.

**Last date for submission of Bids : ~~17.06.2022~~ 11.07.2022 upto 12.30 P.M.**

**Opening of Bids : ~~21.06.2022~~ 13.07.2022 at 3.15 P.M.**

2. The service provider who are fulfilling the specifications stated in Tender Document may submit their Financial Bids (strictly in the format enclosed) in sealed envelope so as to reach us latest on ~~17.06.2022~~ 11.07.2022 by 12.30 p.m. The envelope should be marked as 'FINANCIAL BID FOR AMC OF FIRE ALARM SYSTEM FOR SPPL OFFICE', on its top and forwarded to the address of SPPL mentioned above.

3. Offers from firms not having their own office in Mumbai will not be considered. The SPPL reserves the right to reject any/all applications without assigning any reason whatsoever and also to confirm authenticity of the facts submitted by the bidders.

## **TERMS & CONDITIONS**

### **1. SCOPE OF WORK**

SPPL intends to select firms for Annual Maintenance Contract AMC for Fire Alarm System in the office of SPPL, Mumbai for a period of 12 months. The period of AMC may be extended on existing rates & same terms & conditions for additional one year on performance evaluation by SPPL.

### **2. TERMS OF EXECUTION OF WORK & LIQUIDATED DAMAGES**

The Annual Maintenance Contract would commence from the day of acceptance of the work order issued by the SPPL.

### **3. ELIGIBILITY CRITERIA FOR SHORT-LISTING**

- a) The Service Provider firm/Agency must have installed or maintained Fire Alarm System in at least three Public Sector Undertakings OR Commercial Organizations in Mumbai, during the last five years. (The certificate of service etc. from the concerned Organization where these equipments are mentioned must be submitted). Also Self Attested copies issued by the concerned organizations on or after 01.04.2013 regarding execution of contract and/or Certificate/letter stating about the performance of Fire Alarm System supplied must be submitted.
- b) Similarly, the Firm/Agency should have running contract at least in 03 offices/organizations during the last two years. (Self-attested copy must be submitted)
- c) The Firm/Agency should have their office in Mumbai.
- d) Technical team should be available locally for support i.e. within 2 hrs. of call. The Firm/Agency should have effective machinery for supervision to exercising better command and control over their field staff, service engineers and technicians. The Firm/Agency should have person holding necessary technical degree/diploma/certificate in the equipments which they are dealing. (Copy must be submitted)
- e) The Firm/Agency must be registered under GST & must have Income Tax, PAN. (Self-Attested copy of both of these should be furnished)
- f) The Firm/Agency should have total turnover above of Rs.50 lacs in installation and/or maintenance of Fire Alarm System, during the last three years ending 31.03.2020, 31.03.2021 & 31.03.2022. Copy of balance sheet and profit & loss account should be submitted.

#### **4. EARNEST MONEY DEPOSIT**

Earnest Money Deposit (EMD) of Rs.5,000/- (Rupees Five Thousand only), in the form of Crossed cheque drawn on any Scheduled Commercial Bank favouring “Shivshahi Punarvasan Prakalp Ltd.” payable at Mumbai must be submitted along with the bid. This amount will be forfeited if the vendor withdraws his bid during the period of bid validity or refuses to accept purchase order or having accepted the purchase order, fails to carry out his obligations mentioned therein. Bank Guarantee in lieu of Earnest Money Deposit will not be accepted. No interest will be payable on the Earnest Money Deposit amount. In the event of non-submission of the Earnest Money Deposit of Rs.5,000/-, the proposal will be rejected. The Earnest Money Deposit will be refunded to the bidder only after the completion of the bid process.

#### **5. VALIDITY PERIOD OF THE OFFER**

The offer should remain valid for a period of two months from the date of submission of Bid.

**6.** It is mandatory to submit all the details in the prescribed bid Application, along with the bid offer. In case of non-submission or partial submission of details, the SPPL, at its discretion, may not evaluate the offer & may reject the bid.

The duly filled Bid Application should be accompanied with following:

- i) Bid Application duly filled in with self-attested photo copies of required certificates/documents/proof/P & L & Balance Sheet, Copies of executed contract, as stated in para 3 above.
- ii) Earnest Money Deposit of Rs.5,000/-, in the form of crossed cheque drawn on Scheduled Commercial Bank in favouring “Shivshahi Punarvasan Prakalp Ltd.”

#### **7. PRICE COMPOSITION**

The Service Provider should quote only in Indian Rupees, and not inclusive of Govt. taxes, duties and levies. Taxes, duties & levies if any, will be paid by SPPL separately.

Cost of the equipments and components, required to be replaced will be borne by the SPPL.

#### **8. NO ERASURES OF ALTERATIONS**

Details must be completely filled up in Bid Application. The corrections of alterations, if any, should be authenticated. In the case of the corrections/ alteration are not properly authenticated, the offer will be rejected.

## **9. NO PRICE VARIATIONS**

The offer shall be on a fixed quoted amount basis. No upward revision in the quoted amount would be considered.

## **10. QUOTED AMOUNT FREEZING**

The quoted amount finalized shall remain valid for a period of one year from the date of such finalization with the option to the SPPL to review the said amount if necessary.

## **11. OPENING OF OFFERS**

The bids will be opened on ~~21.06.2022~~ **13.07.2022** at 3.15 p.m. in the presence of the bidders/their authorized representatives. No separate intimation will be given in this regard to the Firm/Agency, for deputing their representatives.

## **12. EVALUATION PROCESS**

Offers will be evaluated on the basis of Lowest bid subject to the compliance with eligibility criteria, other terms and conditions stipulated in the tender document.

However, the SPPL shall be under no obligation to accept the lowest or any other offer received in response to this tender and shall be entitled to reject any or all offers without assigning any reasons whatsoever.

## **13. ORDER CANCELLATION**

The SPPL reserves its right to cancel the order in the event of delay in Service or unsatisfied service.

## **14. MAINTENACE STANDARD EXPECTED & PERFORMANCE GUARANTEE**

Successful Service Provider should submit a Performance Guarantee by way of deposit of an amount by cross cheque for a period of one year drawn on Public Sector Bank equal to 10% of the total cost and the same may be renewable for further period as per requirements. The said deposit will not carry any interest. During contract period Service Provider should maintain the Fire Alarm System in SPPL so as to remain it effective all the time. The Service Provider should attend to all repairs/defect/replacement of spare parts. Failure on the part of the Service Provider to attend the defects within a reasonable period, SPPL on its own will get defects rectified through another agency at the risk and cost of Service Provider. The cost of the spare parts or components required will be borne by the SPPL.

The Service Provider should ensure that the Fire Alarm System reported Breakdown/malfunctioning on any working day is set right by on the same day and in no case later than the next working day. In case, equipment cannot be repaired

within the stipulated period, the Service Provider should provide replacement of the same till the machine is returned duly repaired.

**15.** Service Provider who will be selected will have to execute Annual Maintenance Contract (expenses will be borne by the Service Provider) initially for one year, which may be extended on existing rates & same terms & conditions for additional one year on performance evaluation by SPPL.

**16.** Payment to the Service Provider for the AMC will be made Quarterly basis. Completion of the respective quarter after verifying the bill presented by the Service Provider.

**17.** No reimbursement of cost of any type on any account will be paid to persons or entities submitting their bid.

**18. FORCE MAJEURE**

If at any time during the period of the contract the performance in whole or in part by either party or any obligation under the contract shall be prevented or delayed by reasons of any war, hostilities, acts of god, Public enemy, civil commotion, sabotage, floods, explosions, epidemics etc. then, provided notice of the happening of the any such events is given by either party to the other within 15 days from the date of occurrence thereof, neither party shall by reason of such event be entitled to terminate their contract nor shall either party have any claim for damages against the other in respect of such non-contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist. If force majeure event continues beyond the period of three (3) months the parties shall hold consultation to resolve the problem satisfactorily.
