



1. Quotations in sealed covers are invited from the Contractors so as to reach the office of the undersigned at Shivshahi Punarvasan Prakalp Ltd. Griha Nirman Bhavan, Bandra (E), Mumbai- 400 051 **on or before 31/01/2018 upto 3.00 p.m. for the work of 528 P.T.C. tenements under S.R. Scheme at New Link Road, Kandivali (W), Mumbai – 400 067 --- Washing & cleaning of 254 P.T.C. tenements out of 528 P.T.C. tenements including passages & staircases and cleaning & disinfecting suction tank & overhead tank.**
2. **The estimated cost of the work is Rs. 2,84,318.00** (Rupees Two Lakhs Eighty Four Thousand Three Hundred Eighteen only).
3. The quotations in sealed cover shall be addressed to the Executive Engineer (Dharavi), Shivshahi Punarvasan Prakalp Ltd., Griha Nirman Bhavan, Bandra (East), Mumbai- 400 051. The blank quotations can be downloaded from the tender section of SPPL website www.sppl.biz from **20/01/2018 to 31/01/2018 upto 2.00 p.m.**
4. The quotationer shall quote in ink his percentage offer above/below or at par the estimated cost both in figures and words. The quotation should be submitted in a single sealed Envelope containing forwarding letter, quotation notice and duly filled Schedule-B and signed on each page.
5. The name of work for which quotations have been given should be stated clearly on the envelope containing the quotation and name of Contractor should be written on lower left of envelope.
6. The sealed quotation will be received by the office of Executive Engineer (Dharavi)/SPPL, 5th floor, Griha Nirman Bhavan, Bandra (East), Mumbai – 400 051 upto **3.00 p.m. by 31/01/2018** and will be opened at **3.30 p.m.** on the same day as far as possible in the presence of the contractors/their representatives whosoever remain present at that time.
7. The quantities as shown in Schedule 'B' are approximate. The payment will be made as per actual quantity of work done.
8. The acceptance of quotation shall rest with the competent authority who reserves the right to reject any or all the quotations without assigning any reason for doing so.
9. The quotation submitted by the quotationer shall be binding on him for a period of 180 days from the last date of receipt of quotation.
10. No alternation in the form of quotation or schedule of quantities, specifications shall be entertained.
11. The entire work is to be completed within **180 days**.
12. The work shall be carried out in accordance with I.S. specifications for the particular items and as per the detailed specifications mentioned in Schedule-B.

13. The rates quoted shall be inclusive of all taxes, Octroi Duty and free delivery at site of work and nothing extra shall be paid on any account.
14. The quotationer is advised to visit and examine the site of work and its surroundings before quoting the rate and acquaint themselves with the site conditions.
15. The contractor will have to make his/ their own arrangement at his/their cost for office and stores and safeguard the materials brought on the work and the materials issued by the department if any.
16. The contractor shall provide all labors, tools, pegs, watering and all other materials as required for line out and setting out the layout etc. for the work without claiming any payment.
17. After the completion of the work, the contractor shall remove forthwith all his/ their serviceable and un-serviceable materials from site of work and other debris shall be dumped and leveled as ordered within the scope of work if so ordered without any extra cost.
18. No escalation shall be paid to the contractor.
19. The successful quotationer shall have to enter into A-1 Agreement with the Executive Engineer (Dharavi)/SPPL as per the rules in force.
